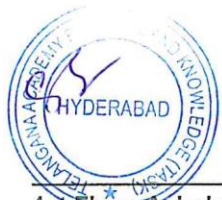
### Eligibility Criteria

3. Academic percentage is not a constraint for a student to register with TASK. However, the eligibility of a student to participate in the Placement process will purely depend on the eligibility criteria of the hiring company.

5. A minimum batch of 30 TASK registered students is required to avail TASK Service offerings/trainings.
